This is further to our letter no. CCL/SEC/2025-26/25 dated July 15, 2025, in relation to Issuance of Equity Shares on Preferential Basis.

Pursuant to Regulation 30 and other applicable provisions of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended ("Listing Regulations"), read with relevant circulars issued by SEBI from time to time, and in compliance with Chapter V of the SEBI (Issue of Capital and Disclosure Requirements) Regulations, 2018 ("SEBI ICDR Regulations"), and upon receipt of approval of the shareholders of Centrum Capital Limited ("Company") at its 47th Annual General Meeting held on August 8, 2025, and receipt of the In-principle Approvals from BSE Limited and the National Stock Exchange of India Limited vide their respective letters dated August 13, 2025, the Fund Raising Committee of the Company, vide resolution passed through circulation on August 28, 2025, has approved the allotment of 4,35,46,454 (Four Crore Thirty-Five Lakhs Forty-Six Thousand Four Hundred and Fifty-Four Only) Equity Shares ("Equity Shares"), at an Issue Price of ₹ 34.38/- per share aggregating to 1,49,71,27,088.52/- (Rupees One Hundred Forty-Nine Crores, Seventy-One Lakhs, Twenty-Seven Thousand and Eighty-Eight and Paise Fifty-Two Only) to the allottees stated in Annexure - B.

These shares shall rank pari-passu, in all respects, with the existing equity shares of the Company. The application for listing and trading approval of the Stock Exchanges for the equity shares allotted as above will be made in due course.
